President's Report October 2014 - February 2015

I would like to begin by thanking everyone who has volunteered to serve with SRDFNS and for their individual and collective efforts to promote our various dance forms. It has been a challenging few months. Poor weather and conflicting schedules have limited our travel to individual clubs special dances. Before the weather got too bad, we attended Lake City Swingers Christmas Dance and Stardusters' 45 years of Dancing Celebration plus their rescheduled Western Night.

At this time, I do not have a complete list of active dancers for our database, however, the numbers from our insured dancers present a troubling trend of declining numbers, club closures, and clubs struggling to keep going. On the positive side, we have clubs who are maintaining, and in at least one case, increasing their numbers.

If we are ever to rebuild our membership, I feel the stakeholders must engage in a serious discussion around all aspects of this organization, including active recruitment of clubs and their dancers. We profess to represent Line and Clog, but do we know if such groups exist in Nova Scotia? We need to find out what attracts our targeted markets. What message does our image send out; i.e. logos, websites, promos? What needs to change? These are just a few topics to open dialogue. Outside of a few pockets, the status quo is not working. I believe we can pretty well bet that to continue the "same old, same old" will give us the same old results -- declining numbers.

Reminders:

- We continue to have Federation vacancies: Vice President, and club representatives.
- Later this year we will need replacement for Bob and Inge Ruohoniemi for CSRDS.
- I will not be reoffering for the president position at the AGM in October 2015.

Our annual Western dance in Nov with beans, chilli, potato scallop, desserts etc. attracted dancers from Hoban's, Tantramar Twirlers & Sussex Corner clubs – 70 in total including Cumb..

In Nov, 21 Cumberland Twirlers joined Sackville club to assist with the 3rd class of MASSIE (Mount Allison Student Semester in English) students for 2014. I don't know who has more fun – the students or the dancers.

Club members danced at Joggins Senior Christmas party for the 16th year. Dancing at a Special Care home in Amherst included getting a few agile residents and the staff joining in for a tip or two.

A church group in Springhill catered to our well attended Christmas party. This not only included a delicious meal, but use of their well decorated hall for evening of dancing. In lieu of a dance fee, members support the local Christmas for Kids campaign.

Following our closing, 16 couples Kettle Set 3 full days for Salvation Army, Amherst – each couple was responsible for a 2 hour shift. A total of \$1,163 was realized for those days. Additionally 2 Springhill couples volunteered 11 random hours in their town.

Our annual Open House was held Jan 13 & 20 with 5 couples & 3 single ladies attending. For personal reasons 1 additional couple could not come until 1st week of Feb / potential for a class of 15.

Report regarding the Halifax Volunteer Conference - Nov. 21/22 2014

The conference is held twice per year to provide training and education to volunteers in the HRM.

Bob Ruohoniemi volunteered at his own expense to participate in three half-day sessions:

- 1. Budgeting Basics
- 2. Funding the Way
- 3. Human Resource Management for Boards

Budgeting Basics for Volunteer Organizations

This session covered: Why Budget; Budget Activities, Types, Goal, Estimating Costs/Revenue, Break-even Point; and Budgeting for an Event. Practical Budgeting exercises were completed. This session provided practical experience for volunteers taking part in planning an event.

Funding the Way

This session reviewed the pitfalls and the successes in obtaining funding for non-profits. A very useful booklet has been produced by HRM Volunteer Services - "Funding Opportunities in HRM", updated each year. It lists many places where applications can be submitted for funding. This a very useful session.

Human Resource Management for Volunteer Boards

This session was the best organized. It covered: Volunteer Engagement, Planning, Recruiting, and Acknowledgement vs. Recognition. A practical guide for "Volunteer Recruitment Ideas" was provided. Many of the suggestions could be applied to recruiting new members to your organization. (the list is attached)

There was a constant emphasis at the all-attendees (over 200 people) meetings to "network" and make contacts with people and organizations that could be of interest to your own group.

The cost of attendance is very low and registration is easy.
