The Canadian Square & Round Dance Society Board of Directors held a teleconference Board meeting on 16 February.

1) The "Dancing Across Canada Badge" final version was approved.

The badge and provincial dangles will be available for purchase at Festival 2014 in Ottawa.

As of February 16th, 2014 meeting there were 713 registrants. There is a 6% cancellation rate. Of the 713 registrants, 120 are singles.

Tours are being arranged to Montreal, QC, Niagara Falls, Toronto and Kingston.

Parking at the convention center has been asked for. The fee for twenty-four hours of parking at the convention center is at the rate of \$20.00 and \$18.00 for twelve hours.

Hearing assists: Dancers requiring hearing enhancement are asked to bring their own receivers - multi channel will be best.

Fashion Show: This is being organized by the Artwear Group. The show will not only show square dance attire but other crafts as well. There will be a five dollar fee for registrants and a ten dollar fee for non-registrants.

Vendor's Village: Will include square dance shops and other crafts.

Trail In Dance: For the first hour and a half will be a caller's showcase. For the last hour and a half there will be three registered callers: Betsy Gotta, New Jersey, Don Moger, Quebec, and Tim Crawford, Ontario.

Financials: The budget is still based on 1200 registrants. Individual day registrations will be made available at fifty dollars per day at the door only.
