This year they completed ten years as the Nova Scotia Directors to the CSRDS. We were proud to be present at the Canadian National in Regina, Saskatchewan when Eric McCormack presented them with the Award of Excellence from the National Society for their many achievements. Their many leadership positions in Nova Scotia include Presidents of Scotia Dancers, organizers of Dice Hill Squares, Chairman of Festival 1999, President of the Federation of Nova Scotia, and Vice Chairman for the 2010 Halifax National Convention. Their volunteer efforts have culminated in two terms as National Society President and two years as Past President during which Bob wrote the Society By-Laws and Rules to comply with the new Canadian Non-Profit Act. A huge "Thank You" goes to Bob and Inge for all of this strong support and superior organizational effort.

During the 2015-2016 dancing year the SRDFNS had 21 member clubs in the SRDFNS and there were 2 other active clubs who were not members. These include square dancing from beginners to challenge, the Bluenose RV Squares dancing on six summer weekends, community dancing for seniors, 2 round dance clubs, and 2 contra dance clubs. We are pleased to report positive signs of new dancers in both round dance clubs, and the Cumberland Twirlers continue to have good success with their January classes.

Our website continues to function as a source of information for active dancers and those looking for information about our activity. Thanks go to Gary Welch for his dedication in keeping it up-to-date and to all those who pass information along to aid that process.

We look forward to this new dance season with hope for many more opportunities to share the joy of dance.

DANS Report, October 2016

During the Spring Dance Nova Scotia did a major update of their website. As part of that process they requested a short overview of the Federation (We are ... We promote ... Our activities...)

Here are some of the things DANS has been up to:

- -- DANS helps choose the dance figure who delivers the International Dance Day Message for Canada. This year was Susanne Chue from Mocean Dance here in Nova Scotia. (Mocean Dance's performance of Sable Island brought a packed house at La Nouvelle Scene during the Canadian Dance Festival in Ottawa.)
- -- Elizabeth Mac Donald returned as our National Dance Week / International Dance Day coordinator.
- -- Dare to Dance School Challenge was hugely successful. Participating schools have students and staff dance for at least 20 minutes sometime during Dance Week. Seventy schools in Nova Scotia registered in 2016 with an estimated 14,910 students dancing this year. It is the single largest NDW event in Canada.
- -- Dare to Dance for Seniors was initiated this year with 4 Senior facilities involved.
- -- Dance NS continues to fight for the future of dance, in particular the need of cultural infrastructure to house dance schools and performance spaces so that young dancers can think about building a career from here in Nova Scotia.
